The Schedule

Wednesday – September 16, 2009

8 a.m. – 5 p.m.*

Problem Gambling Treatment Foundations (8 CEU)

Presenter: Linda Graves, MS, NCGC-II

This workshop lays the groundwork for understanding how to treat problem gamblers. The presentation will discuss definitions of gambling and types of gamblers. The participants will be introduced to several different assessment tools for problem gambling. The progression of the disease will be discussed, as well as the progress of the disease for the partner of the gambler. Workshop participants will learn about the effects of problem gambling on family members. The instructor will use interactive learning and films to illustrate discussion topics.

Thursday – September 17, 2009

8-11 a.m.*

Clinical Supervision: How to Be an Evidence-based Clinical Supervisor Instead of an Error-based Clinical Supervisor (3 CEU)

Presenter: Deborah Haskins, PhD, LCPC, NCGC, BACC

People often become clinical supervisors without having ever taken any education or skills training in how to be effective supervisors. This workshop will review evidence-based clinical supervision models and strategies to support mental health professionals in optimal performance. Participants will receive sample clinical supervision process materials to use as clinical supervisors.

Noon-3 p.m.

Mosaic or Melting Pot? Incorporating Cultural Diversity into Problem Gambling Treatment and Prevention (3 CEU)

Presenter: Deborah Haskins, PhD., LCPC, NCGC, BACC

Problem gambling is an equal opportunity addiction and does not discriminate against individuals, families, and communities when developing pathological gambling problems. Problem gambling counselors must, therefore, integrate cultural diversity with their interventions/programs in order to provide culturally relevant services. This workshop will discuss the Multicultural Awareness Knowledge and Skills model to help participants develop competency in assessing diverse clients.

3-5 p.m.

Case Planning with Problem Gamblers (2 CEU)

Presenter: Linda Graves, MS, NCGC-II

Treating problem gamblers effectively requires a holistic approach, which includes six domains. The workshop will discuss methodology in developing a treatment plan with problem gamblers or their family members. The instructor will describe each of the six domains and illustrate how a case plan matrix can be used to prioritize treatment planning and move through treatment issues.

Friday – September 18, 2009

8:30 a.m. – 12:30 p.m.*

Evidence-based Best Practices for Successful Groups in Outpatient Counseling (4 CEU)

Presenter: Daniel Smith, MA, LCSW, CCGC, NCGC-II, BACC

This workshop will address similarities and differences in approaches to substance abuse and problem gambling, and practical gambling-specific applications. Includes discussion on and exercises that address five characteristics that all addictive behaviors have in common, which drive the treatment plan. Incorporates discussion on subtle differences between support groups such as Alcoholics Anonymous, Narcotics Anonymous, and Gamblers Anonymous, and compares them to practice in outpatient group counseling. A matrix of development phases of recovery and deepening levels of recovery will be presented.

1:30-4:30 p.m.

Evidence-based Best Practices for Families/Couples in Outpatient Counseling (3 CEU)

Presenter: Daniel Smith, MA, LCSW, CCGC, NCGC-II, BACC

An evidence-based experiential presentation on incorporating group counseling techniques described in the morning session, but modified to suit family members or couples in which one or both of the partners is a problem gambler. Review of the recovery process for both the gambler and their significant others, followed by discussion on different approaches to mixed and family only group practice in an outpatient setting.

Linda Graves, MS, NCGC-II, is Problem Gambling Program Manager, Division of Alcohol and Substance Abuse, State of Washington. Linda was previously the Deputy Director for the Delaware Council on Problem Gambling. Linda served as Chair for the National Problem Gambling Helpline Committee from 2001-2005. She served as a member of the Delaware Certification Board for six years. She was recognized as Counselor of the Year by the Delaware Association of Addiction Professionals in 2005. She was awarded the Service Award in 2003 by the National Council on Problem Gambling.

Deborah Haskins, PhD, LCPC, NCGC, BACC, is Assistant Affiliate Professor and Director of Undergraduate and Masters Field Education in Psychology at Loyola College in Maryland. Her counseling expertise includes sexual abuse recovery for women, substance abuse aftercare treatment, problem gambling counseling, grief and loss, and integrating religion and spirituality in human functioning and practice. She serves on the Maryland Board of Professional Counselors and Therapists, and on the International Gambling Counselor Certification Board.

Daniel Smith, MA, LCSW, CCGC, NCGC-II, BACC, is a licensed clinical social worker, and a designated Board Approved Clinical Consultant for the International Gambling Counselor Certification Board.
